

Requirements:

- 1. Closest Relative (Name of closest Relation wife section above on Form A) Must be a Man as a witness for the wife. In Case of Not having a Male Relative for the Wife, She Must have two female relatives, one of the two must fill her details above as closest relative for the wife section, but both must attend all hearings.
- 2. Proof of Payment of filling fee
- 3. ID copy or Passport
- 4. Copy of Judgment of Sharia Court of Appeal
- 5. Marriage certificate copy (if available) if not available, Letter of consent to marriage stating the marriage do exist (write what happened when entering into marriage, any details that you can remember for example, where marriage ceremony took place, who conducted marriage ceremony, who were witnesses to both sides husband and wife. This must be according to the type of marriage given above, either Islamic, civic or cultural. And if it was in the church, that is included among Cultural. Just give any detail you can remember about how you consented to marriage (all this information is not needed if copy of Marriage certificate is attached either Islamic, Civic, Cultural or both of the two.

NB: If there was no marriage ceremony took place that means it was mutual understanding of two adults who consented to live as husband and wife without any witnesses to the union for some reasons, just state the reasons. Don't worry you will be helped.

Inshallah you will be served with sincere dedication to reach possible solution that will settle your hearts between husband and wife in accordance with justice established by sharia in accordance with Quran and Sunnah.
